Effective May 6, 2013, the Issuer was delisted, thereby removing this condition and resulting in the issuance of the options.
- 2. 25% of the options vested on November 8, 2012. The remaining options vest in a series of 36 successive monthly installments for each month of service beginning December 8, 2013.
